Ratings of Congress:

How Your U.S. House and Senate Members Voted on Key Small Business Issues

Most members of Congress exclaim to support small business owners and entrepreneurs through their work on Capitol Hill. However, when it comes to how U.S. Senators and House members actually vote on legislation that impacts the profitability and survivability of small firms, their actions sometimes don't match up to the rhetoric. The purpose of SBE Council's ***Small Business Scorecard for the 111th Congress*** is to get beyond the politics and posturing, and gauge exactly how members of Congress vote on issues critical to entrepreneurs.

The legislative thrust of the 111th Congress has been decidedly anti-growth and anti-small business -- an endless wave of bills that increase costs, paperwork, red tape and taxes on the nation's job creators. In addition, unhinged spending has created a precarious and unstable fiscal environment that threatens to undermine our nation's competitiveness and ability to support robust job creation and investment. Unfortunately, and despite small business opposition, measures that hurt entrepreneurship steadily advanced in the 111th Congress, including: a massive health care bill that increases taxes, compliance burdens and the cost of insurance; tax hikes and the threat of more to come; new workplace mandates that bring uncertainty and the opportunity for increased legal action against small businesses; initiatives that will drive the cost of energy higher; and excessive spending that will drive the U.S. further into debt while increasing the likelihood that taxes will go higher for small business owners.

The legislative and policy environment has not only harmed the bottom line of business owners at a time when our nation can least afford it, but it continues to chip away at business confidence. Hiring remains anemic and business investment is weak. The only good news out of the 111th Congress is that many other bad bills did not make their way to President Obama's desk for his signature.

Pro-growth, pro-small business legislation is central to getting our nation's economy back to strong levels of growth. If the nation's economy is going to get moving again, Congress must first help small business owners with legislation that does not drive taxes or their business costs higher. After all, entrepreneurs are the engine of the U.S. economy. As reported by the Small Business Administration's Office of Advocacy, small firms (with fewer than 500 employees) generate roughly two-thirds of net new jobs; employ more than half of private sector workers; generate more than half of nonfarm private GDP; make up 97 percent of exporters; generate more than 30 percent of export value; and produce 13 times more patents per employee than large patenting firms. Studies have found that during recessions and downturns, small businesses create all the net new jobs and have led the nation out of these tumultuous periods.

For the 111th Congress, SBE Council has scored members of the U.S. Senate on 27 key votes, and members of the U.S. House of Representatives on 22 votes. The findings of SBE Council's ***Small Business Scorecard for the 111th Congress*** are found in this report, including individual ratings of U.S. House and Senate members.

17. Health Care and Education Reconciliation Act of 2010 (HR 4872): Pro-small business vote was nay – March 21, 2010 – Roll Call 167: 220 yea, 211 nay.
18. Health Care and Education Reconciliation Act of 2010 (HR 4872): Agree to Senate amendments. Pro-small business vote was nay – March 25, 2010 – Roll Call 194: 220 yea, 207 nay, 3 nv.
19. On motion to recommit HR 5486 for repeal of individual mandate in ObamaCare: Pro-small business vote was yea – June 15, 2010 – Roll Call 362: 187 yea, 230 nay, 15 nv.
20. Democracy is Strengthened by Casting Light on Spending in Elections Act, or DISCLOSE Act (HR 5175): Would limit the voice of small businesses in the policy and political arena. Pro-small business vote was nay – June 24, 2010 – Roll Call 391: 219 yea, 206 nay, 8 nv.

21. Conference report for the Wall Street Reform and Consumer Protection Act of 2009 (HR 4173): Pro-small business vote was nay – June 30, 2010 – Roll Call 413: 237 yea, 192 nay, 4 nv.
22. Vote to repeal 1099 mandate in ObamaCare, but included tax increases (HR 5982): Classic “robbing Peter to pay Paul.” Pro-small business vote was nay – July 30, 2010 – Roll Call 514: 241 yea, 154 nay, 37 nv.
